Figure 1a: Quarterly Health Service Sight Tests, 2003 to 2015 - non-zero y-axis

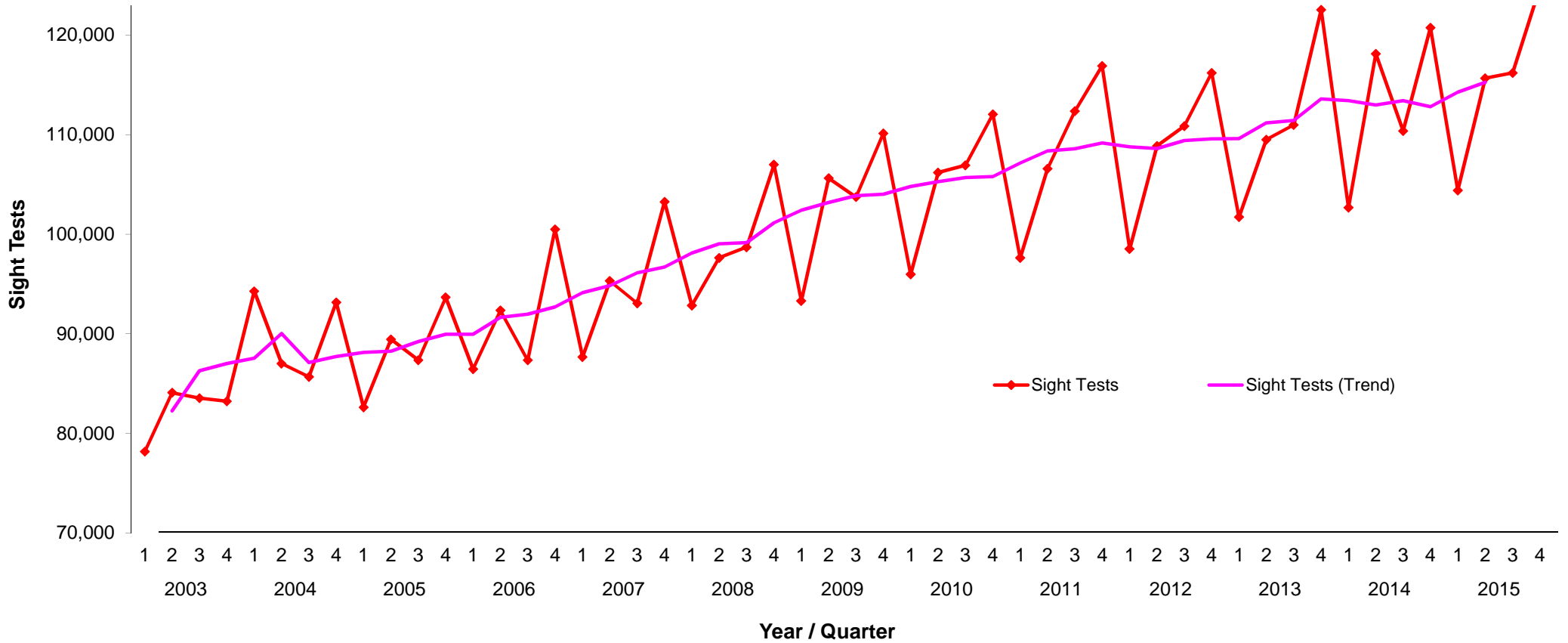


Figure 1b: Quarterly Health Service Vouchers 2003 to 2015 - non-zero y-axis

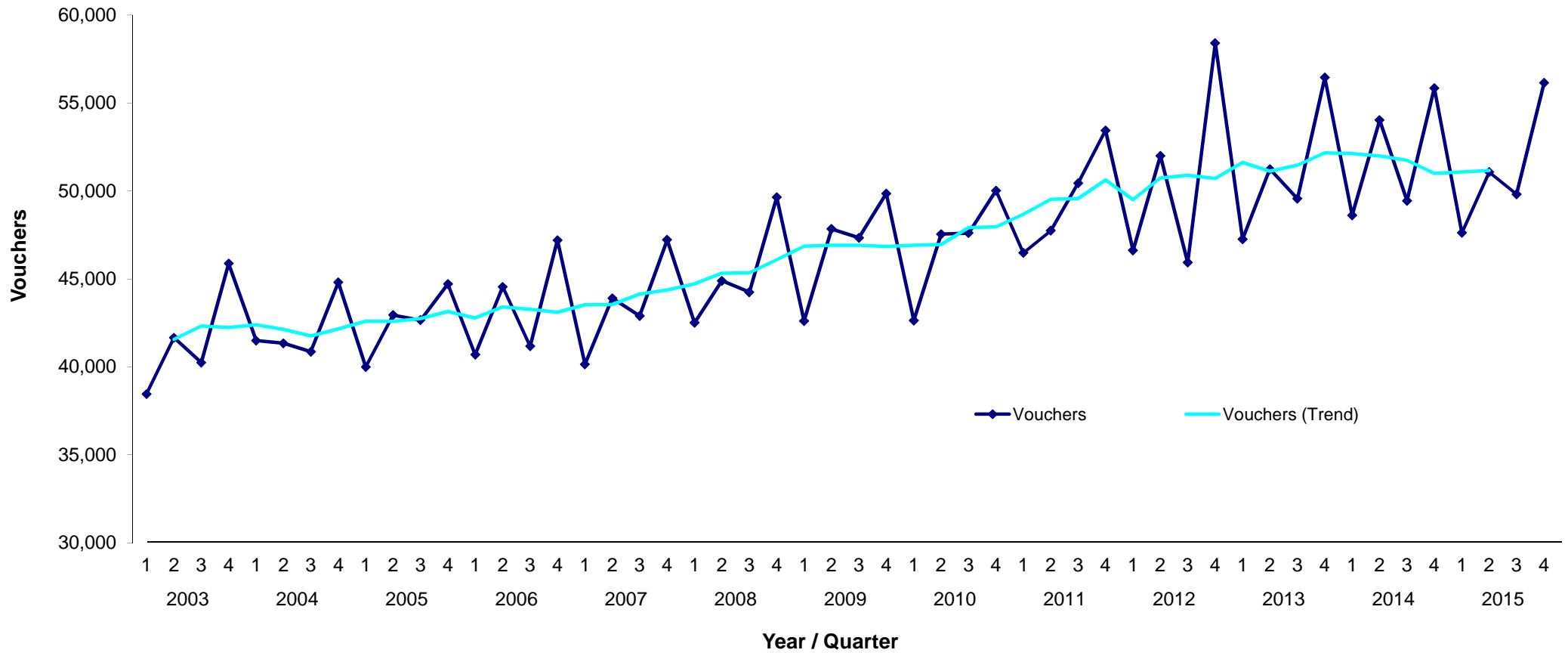
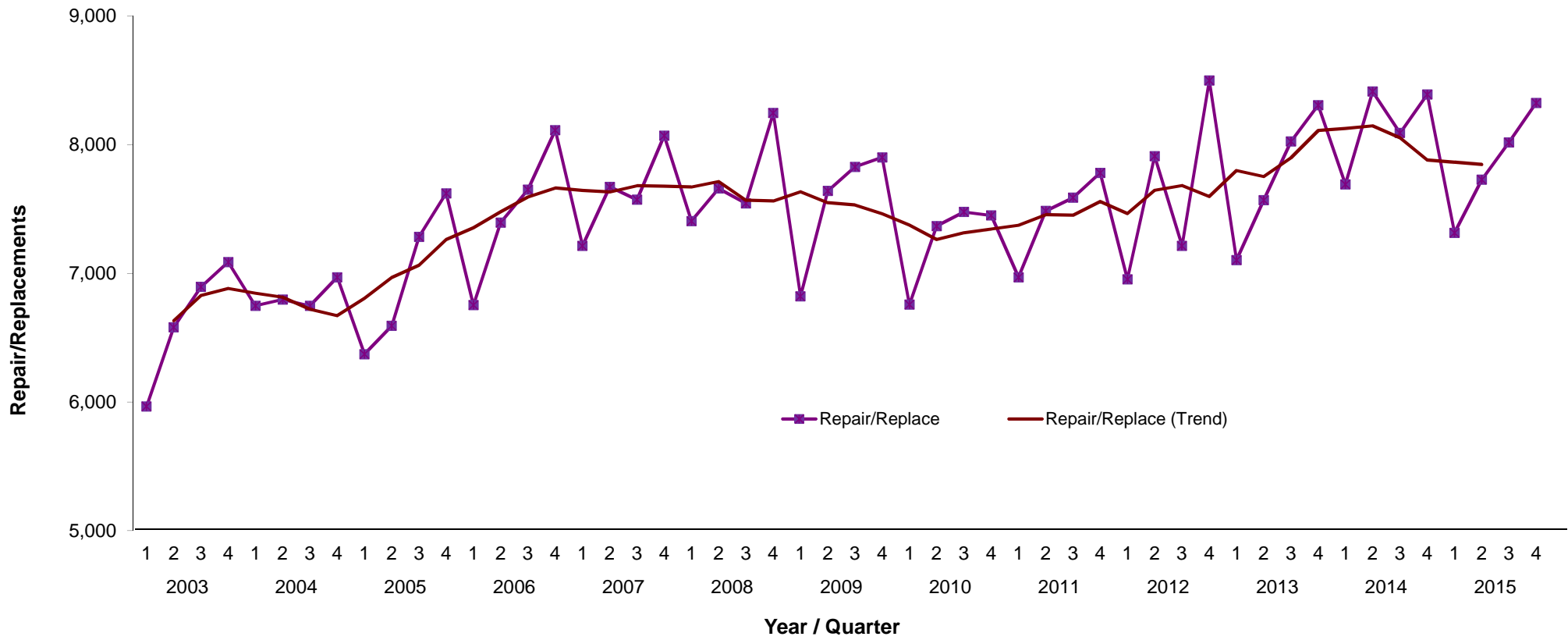


Figure 1c: Quarterly Health Service Repair/Replacements 2003 to 2015 - non-zero y-axis

## Notes

1. Ophthalmic statistics are compiled from claims received and paid through the FPS Ophthalmic Payment System. The system records claims for Health Service sight tests, vouchers and repairs and automates the payment process. The system is designed to be a payment system rather than an information system and there may be anomalies in the data due to scanning errors. However where feasible quality checks have been carried out and information sought from the original paper form where possible.
2. All data in this report relates to the date the activity was processed and paid on the system rather than activity date. The time periods for submission of payment claims are six months from the date of test for sight test claims and three months from the date of supply for vouchers and repair/replacement claims.
3. Data excludes sight tests to prisoners in Northern Ireland.
4. Population estimates and rates are calculated using the population registered in Northern Ireland for Health Service treatments at July - the mid-point for each year unless otherwise stated.
